Early Learning Center

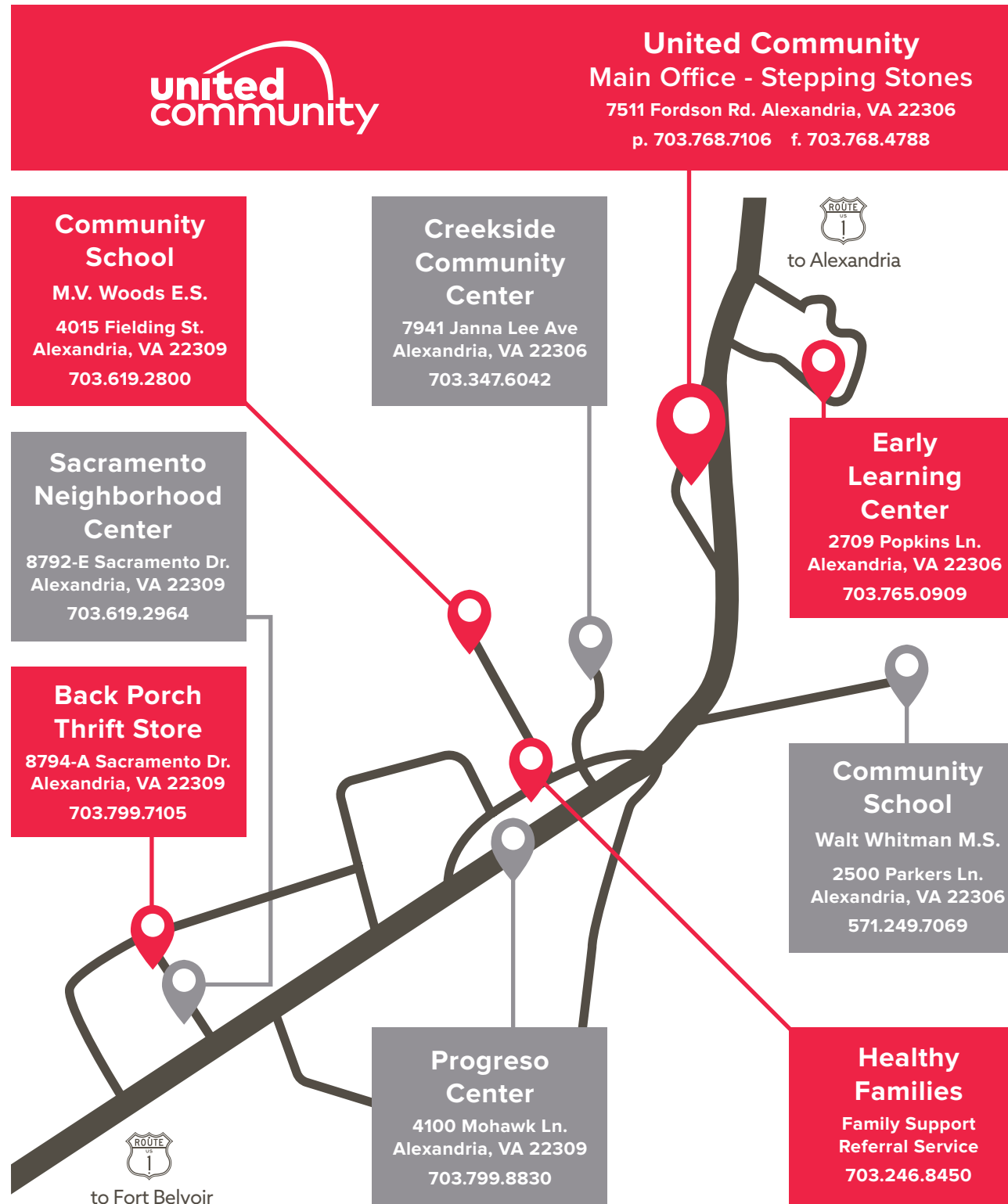
Provides an enriching environment for infants, toddlers, and young children from six weeks to five years old. Special emphasis on social and emotional development along with an evidence-based curriculum ensure that our children are prepared to learn when they enter Kindergarten.

Progreso Center for Literacy and Citizenship

Offers immigrants and refugees a safe learning space where students can establish positive relationships and create support networks. English as a Second Language, (ESL), classes and legal professional immigration services empower immigrants to help them achieve their economic and social goals.

Community Schools Walt Whitman M.S. and Mount Vernon Woods E.S.

A program in public schools that builds key partnerships with community resources. We provide family and student support services, health services, enrichment activities, after-school and summer family and community engagement activities, community sponsorship, partnership, and volunteer infrastructure.



Stepping Stones Program

Provides food assistance, rental assistance, utilities assistance, dental and medical prescription assistance, case management, job readiness assistance, transportation assistance, financial literacy, and other basic needs assistance.

Healthy Families Program

A nationally recognized child abuse prevention program to promote healthy child development, and prevent child abuse and neglect, for families with children pre-birth to age 3. Healthy Families provides the tools, guidance, and support that families need to build a healthy, successful life.

Out-Of-School Youth Program

After-school and summer programming offered at the two community centers — for children and youth in grades 1-12. Activities include STEAM focused learning, homework help, tutoring, and mentoring. Parents also participate in fun family enrichment events and other activities to support their child's academic success.

Opportunity Neighborhood Mount Vernon

A collective impact initiative where residents, local government, community organizations, faith groups, schools, and business partners work together to create supports and possibilities to ensure the well-being of children and youth by reducing barriers to opportunity.

Back Porch Thrift Store

A thrift store serving our community and clients. All proceeds stay in the community.
